2024 Rules, Conditions, & Information for Clinical Research Grants

Faculty members are encouraged to submit original proposals dealing with relevant topics of clinical research and translational research in veterinary medicine and human medicine. Collaborative, multidisciplinary proposals will receive special attention and consideration. Only one project will be funded per faculty.

Grants are available to support proposals up to \$ 10,000 for one fiscal year.

All funds are intended to be used within the fiscal year (July 1, 2024-June 30, 2025). A one year, no-cost extension may be considered and approved by the Research Committee.

Application Deadline: January 31, 2024 (5:00 P.M. Pacific Time) [with notification by June].

- 1. Any faculty member, independent of rank, may apply for support.
- 2. Only one (1) proposal per PI will be funded during any given funding period.
- 3. Multidisciplinary proposals involving Co-PIs in Biomedical Science and Clinical Science departments will receive special attention.
- 4. The grant funds can support salary and supplies but cannot be used for travel expenses. (Salary CANNOT be used for someone who already receives 100% salary on 1.0 FTE)
- 5. Review Process: The proposals will be reviewed by the CCVM Research Committee. Members of the Committee who are not expert in all subjects and, therefore, may consult an outside reviewer.
- 6. The awarded grant funds need to be spent in one fiscal year. No extensions will be given unless considered and approved by the CCVM Research Committee.
- 7. If the research requires an IRB or IACUC approval, grant funds will be only awarded after the approval is obtained.
- 8. The proposal should be a maximum of 3 pages long (NOT including Cover Page, Budget, Budget Justification, References), or 4 pages if Preliminary Results are included.
- 9. Font should be no smaller than 11 point (Fig. captions can be 10 pt.); use ½ inch margins.
- 10. The grant application is to be submitted as a single PDF file, consisting of (in this order):

A. GRANT APPLICATION COVER PAGE

B. BUDGET PAGE:

The maximum award for this year is \$10,000 [if more funds are needed please justify] Grant budget guideline:

- i. Requested budget is realistic for the completion of the proposed project objectives
- ii. Cost for budgeted line items are accurate and reasonable
- iii. Justification for requested budget clearly explains the necessity of expected costs and expenses

C. PROPOSAL OUTLINE (3-page limit):

- i. Hypothesis and Objective(s)
- ii. Background/Relevance
- iii. Preliminary Data, if applicable (1 page maximum)
- iv. Experimental Design and Methods

 Include a description of design, experimental methods, species and number of
 animal treatments, data analysis methods, and potential pitfalls and limitations.
- v. Potential impact on animal health and future research

D. REFERENCES (2 page maximum)

- 12. The awardees must provide a **Final Report**, which includes accounting, on the research at the end of the funding period (**report is due by July 31, 2025**).
- 13. The awardees are expected to present their project findings during the year following funding.
